## 2015 Giant Hogweed Control Program

This year's Oswego County control program was part of a state-wide effort through a partnership with NYS Department of Environmental Conservation and funded by a federal grant (NY-13-DG-11420004-065) through the US Forest Service

Based upon the 2014 control season, the Oswego County Soil and Water Conservation District put together a Request for Proposals (RFP) to chemically control Giant Hogweed in Oswego as well as Cayuga Counties for 2015. This request was sent out in early March, having a response date of March 27th. The contractor (Chase Enterprises, Inc.) was then selected in April of 2015.

A contracted figure of \$7,060.56 was limited to Oswego County sites only. For additional chemical treatment performed in Cayuga County an extra \$1,000.00 was made available, bringing the total figure for chemical control to \$8,060.56.

Additionally, there was an expenditure agreement to perform mechanical (mowing) control in the amount of \$1,500.00, which was delegated in controlling three solid acres of Giant Hogweed.

Control program began on May 28th and ended on July 17th.

The solid three acres of mowed Giant hogweed was mowed four times during 2015.

During the course of the 2015 control season, the NYS DEC provided Oswego County with new educational information regarding Giant hogweed. They were either in poster or brochure forms, with their respective distribution located below.

Two formal educational presentations were provided to others about GH and the control program.

Soil and Water district controls giant hogweed

The Oswego County Soil and Water Conservation District (District) will be entering its fourth season of controlling the highly toxic invasive species Giant hogweed (Heracleum mantegazzianum) in Oswego County.

Giant hogweed is native to the Caucasus region of Eurasia. The plant was introduced to Great Britain in the 19th century. It was later transported to the United States and Canada as a showpiece in large, grand gardens at the time. In fact, one of the plant's first North American plantings was in gardens near Highland Park in the City of Rochester, NY. The plant looks like Queen Anne's Lace on steroids. It grows between 8-14 feet tall with two-inch thick stems resembling bamboo, flowers two or more feet across and leaves that are lobed, deeply cut and up to five feet across

Giant hogweed was a favorite for bee keepers due to the size of its flower heads (umbrels), as well as for the seeds that can be dried and used as a spice in cooking. Giant hogweed is also a public health hazard because of its toxic oil that can cause second or even third degree burns; and blindness, if accidentally introduced into the eyes. These burns are light sensitive, meaning that they can remain persistent and reoccur for J a number of years.

The New York State Department of Environmental Conservation has supported Oswego County's

control program through a federally funded grant from the US Forest Service agency. This grant has allowed the district to hire a certified applicator to treat and

control giant hogweed. The plants are currently emerging throughout Oswego County, primarily from Interstate Route 81 Corridor, westward to the county line with Cayuga County. Some thirtyfive sites will be treated, as well as another fifteen sites will be monitored in 2015.
